



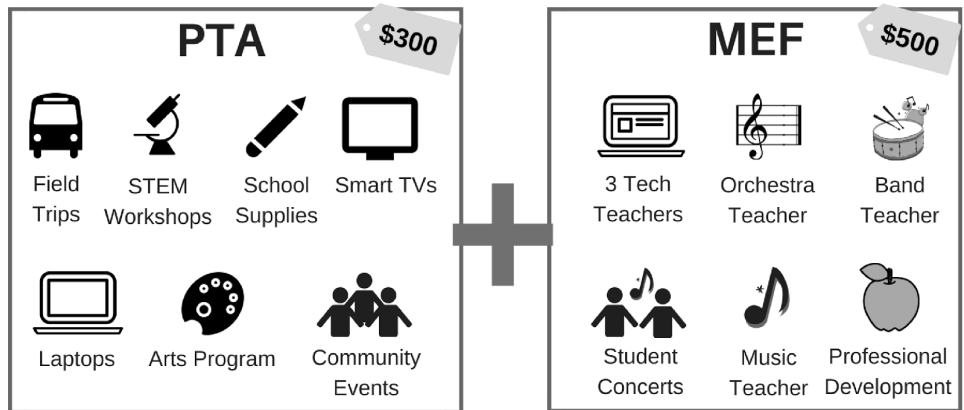
Stronger Together

Welcome back to school! We hope you all enjoyed your summer. Thank you for supporting Green Hills PTA and Millbrae Education Foundation (MEF) last year. This year, the PTA is working closely with MEF and the Millbrae Elementary School District to bring more enrichment beyond Music and Technology to every student.

Quality enrichment programs are essential to prepare our kids to lead in today's innovation economy. Every student in our schools should be given the opportunity to reach his or her full potential!

PTA and MEF are working together to give every child equal access to enrichment programs. Last year MEF raised \$408,000 and **35% of families** contributed. In the past, each PTA sourced their programs separately from different vendors. Your participation in MEF is important because, going forward, we will coordinate enrichment programs district wide. A well-funded MEF results in high quality programs for lower overall cost.

Millbrae is the lowest funded school district in San Mateo County. \$400,000 is only enough for Music and Technology teachers in all 5 schools. We need to raise more money to expand our programs to more subject areas. This school year, PTA and MEF are looking at **adding new programs for Sports and the Arts district-wide**.



Our suggested tax-deductible donations amounts are:

- \$500 (or \$50 for 10 months) per student to MEF and
- \$300 (or \$30 for 10 months) per student to PTA/O.

FAQ

Q: How do MEF and PTA support my child's education?

MEF and PTA both support your child's education in complementary ways. PTA provides school-specific support, while MEF provides support for the whole district, including hiring teachers and funding district-wide programs. Supporting both means a better school system, which is better for all of us.

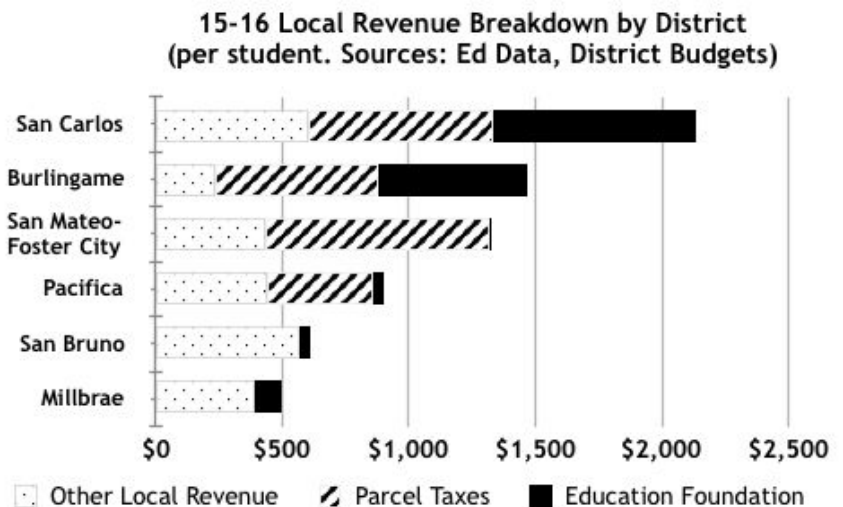
Q: I already pay for property taxes, doesn't this money help our schools?

Some Millbrae residents pay a relatively high amount in property taxes because of high property values. Unfortunately there is no relationship between the amount any resident pays and the money received by our schools. The school district budget is effectively determined by the state and not by local property taxes. The Local Control Funding Formula (LCFF) means that all districts receive funding based on the average daily attendance (ADA) of students. The higher the attendance rate, the higher the funding received. Additional funds are distributed based on student demographics and socioeconomic status.

Q: How do other school districts have more funding than Millbrae Elementary School District?

Other school districts receive funds beyond minimum LCFF/state/federal funding through local revenue sources.

This includes **donations from their education foundations, parcel taxes and other site-based revenue** (e.g. school facility rentals). A parcel tax would provide a stable local source of revenue for Millbrae schools. A stronger education foundation is also essential to provide a competitive, well-rounded education for all our children.



Q: What if I cannot afford to pay the suggested donation amounts?

Any donation amount from your family will help benefit your child and his/her education. PTA and MEF welcome any contribution no matter the amount. You can also volunteer your time and talents during the year.

Q: How do I find out if my company provides a Corporate Matching/Charitable Matching Gift program?

This is an easy and great way to double the impact of your donation! Visit doublethedonation.com/millbraekids to find out if your company has a matching gift program and how to apply. You may need to provide information such as donation date, amount, and our tax ID or EIN (MEF: 41-2258685 and PTA: 94-6172234).

Q: Are school supplies still included in my PTA donation?
